Pursuant to the Court's Order of June 6, 2023, Petitioners The 200 For Homeownership, et al., herby submit the following preliminary and non-binding Statement of Issues to be Raised in this Petition for Review of EPA's final action entitled California State Motor Vehicle and Engine Pollution Control Standards; Heavy-Duty Vehicle and Engine Emission Warranty and Maintenance Provisions; Advanced Clean Trucks; Zero Emission Airport Shuttle; Zero-Emission Power Train Certification; Waiver of Preemption; Notice of Decision, published in the Federal Register at 88 Fed. Reg. 20,688 (Apr. 6, 2023) ("Waiver Grant").

1. Whether the Waiver Grant exceeded EPA's statutory authority under Section 209 of the Clean Air Act;
