

IMPORTANT NOTES:

These tables likely do not contain all SIN List chemicals or all companies producing or importing SIN List chemicals in the U.S.: EPA regulations under the Toxic Substances Control Act (TSCA) allow a company to claim the identity of a chemical it produces, or the company's association with a chemical, to be confidential business information. Any such chemicals or companies were excluded from the public version of the EPA database, and hence are not represented in these tables.

In addition, while we used the most recent public data on U.S. chemical production and import, they are somewhat dated, as they were collected by EPA in 2006 for activity during the single calendar year 2005. Given the dynamic nature of the chemical market, both from year to year and between 2005 and the present, some of the data we report here on chemicals, their production/import volumes and their associated companies may well have changed.

According to EPA: "There are two CAS numbers for HBCD: 1,2,5,6,9,10 hexabromocyclododecane (CAS 3194-55-6) is an HPV chemical that was manufactured or imported in the U.S. between 10 and 50 million pounds in 2005. Hexabromocyclododecane (CAS 25637-99-4) is a moderate production volume (MPV) chemical manufactured or imported between 10 thousand and 500 thousand pounds in 2005." However, only the former is listed in the 2006 IUR database, so data included here are for that CAS number.

of sites in 2005 – indicates the number of sites at which companies reported producing or importing the chemical above the reporting threshold; a site is counted twice if the chemical is reported as both manufactured and imported at that same site; based on the most recent publicly available data collected in 2006 for calendar year 2005; excludes any sites that companies claimed to be confidential business information.

Subject to mandatory testing under TSCA – indicates whether EPA has required testing of the chemical under TSCA through a Section 4 test rule or Enforceable Consent Agreement; see Appendix in main report for details.

Tested voluntarily – indicates whether the chemical has been tested in the U.S. under a voluntary program. The Challenge is the U.S. EPA's HPV Challenge Program; entries listing "OECD" refer to Challenge chemicals that are being addressed under a sister HPV program operated under the auspices of the Organization for Economic Cooperation and Development; entries listing "OECD2" refer to chemicals being tested under the OECD program independent of the Challenge; "Orphan" refers to a Challenge chemical that has not been sponsored and for which data development is not taking place.

Voluntary program status – indicates whether testing and data development under the associated voluntary program are done, ongoing or not begun.

Regulated under TSCA – indicates whether a chemical is or has been subject to a TSCA regulation; "SNUR" refers to its coverage under a Significant New Use Rule; "TSCA Sec. 6" indicates a chemical is subject to a regulation restricting its product or use, issued under Section 6 of TSCA; "IUR exempt" indicates that a chemical has been exempted from the regulation that requires periodic reporting of production or import under EPA's Inventory Update Rule (IUR).
