<u>ORDER</u>

Upon consideration of the motion to recall the mandate, the responses thereto, and the reply, it is

This order recalls the mandate for a limited period in order to give EPA time to "determine whether to seek panel rehearing, rehearing *en banc*, or pursue other relief." EPA Mot. at 2. To stay issuance of the mandate for longer would hand the agency, in all practical effect, the very delay in implementation this panel determined to be "arbitrary, capricious, [and] . . . in excess of [EPA's] statutory . . . authority." 42 U.S.C. § 7607(d)(9)(A), (C).
